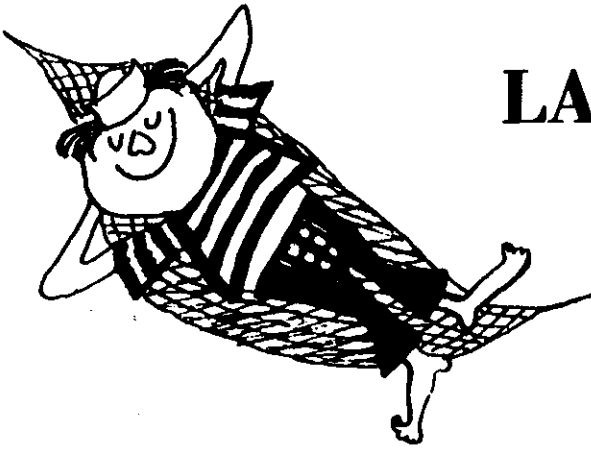

- 1) To consider and if approved, an amendment to the By-Law number 1 article 6(b) which reads:

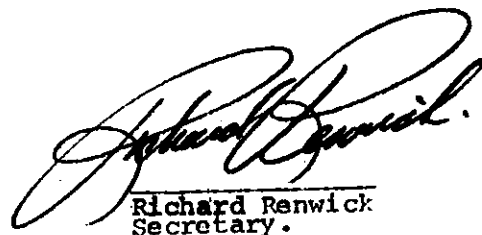
6(b) "The Board of Directors shall be composed of a Commodore, Vice-Commodore, Secretary-Treasurer and two (2) additional Directors".
