
From the "Loudhailer",


Have a go at the "speed king" trophy, the rules are established and available.

## NOTE FROM THE COMMODORE

There were three resolutions passed at the Club Meeting held May 11th which are important to each and every member. The first of these resolutions that was passed states "Members shall be assessed 20 hours of work excluding clean-up duties or be levied \$100.00". This resolution was passed because the membership felt it was unfair to have the same regular people come out to work parties every week, whereas other members had the same access to Club facilities and spent very little time helping with their maintenance. The time members worked towards Club maintenance is charged at \$5.00/hour so make sure your time is recorded in the record book so you receive the proper credit.

The second resolution passed reads "After June 1st, 1980 all cars must be parked in the parking lot and only temporary parking for unloading will be allowed by the boats". This program is now in use and it has been found that on race nights the parking lot is a little too small to handle all vehicles which arrive. We would ask that you ensure all guests park in the new parking lot area and that any other cars be parked as close to this area as possible when room is limited so free access to the boats and Club House are maintained.

The third resolution passed established a policy for living aboard boats that reads "Any member can sleep on his boat at the Club premises for casual purposes for a time period not to exceed three consecutive calendar days on his own decision. Prior clearance from the Executive is required for a member to live aboard his boat at the Club for any period from three consecutive calendar days to seven consecutive calendar days. Any extension beyond seven consecutive calendar days shall be at the sole discretion of the Executive and shall be to a maximum of one further seven day period." It was the general feeling of the Membership that this resolution would protect the rights of all Club members and ensure that each member had the maximum flexibility in the quiet enjoyment of their boat and the Club facilities.

The Freedom Festival Regatta is coming up on June 29th and under the capable guidance of Rick Renwick, it has been a fun week-end for the past couple years even though there was wet weather. This year Rick, Curly and John have a fine event planned, so please talk to your friends from other clubs and invite them to join us.
